SAFETY

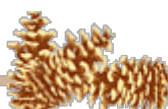

With a land management plan in hand, it is time to fire up the chainsaws. We recently received a timely email from Carolyn Kuebler from MyLandPlan.org about the importance of safety. According to the CDC, approximately 36,000 people are sent to the hospital each year due to injuries while using a chainsaw.

Then she gives us three "make sures":

- 1) Make sure that your chainsaw is maintained according to your manufactory's instructions, properly sharpened and oiled.
- 2) Make sure your chainsaw matches the job.
- 3) Make sure you have the right safety gear:
 - Hard hat
 - Safety glasses
 - Hearing protection
 - Heavy work gloves
 - Chainsaw chaps
 - Boots that cover your ankle

And get properly trained! Fortunately, we live in a state that offers that training. The New Mexico Forest Industry Association (NMFIA) <http://www.nmfia.org> administers the Forest Worker Safety Certification classes in New Mexico. The three day safety class is open to land owners. It thoroughly covers chainsaw safety and situational awareness. And it includes CPR and First Aid training. The cost is \$185 per person. Contact Jose J. I can personally attest that this class is well worth the investment because I took the course when it was first offered. Moreover, I have paid to have employees take the course. A great investment! In addition to learning about safety, we learned how to cut more efficiently. And we met folks interested in possibly working on our projects. We also informally learned about the availability of funding and cost share programs in which others were participating.

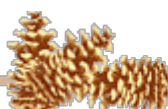

(1) 2016 SPRING TREE FARM FIELD DAY

Over 60% of Vermejo Park is comprised of classic southwestern ponderosa pine forest, thus making its restoration back to a healthy, sustainable landscape is one of their most important priorities. To that end, the ranch is currently thinning the abnormally thick stands by cutting small diameter trees to make posts and poles as well as some sawlog trees of poor health and quality. 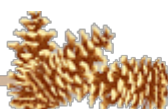

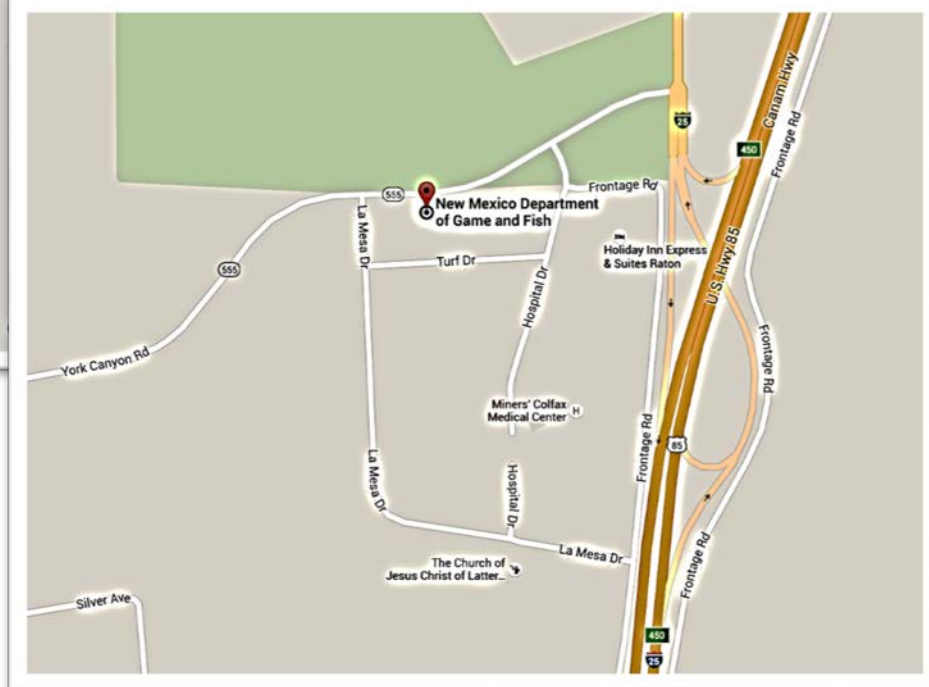
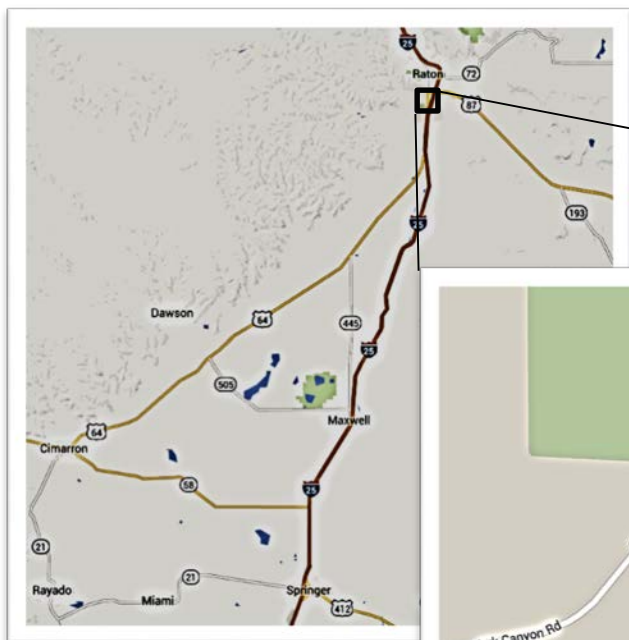

- 2:55-3:00 PM Return to NM Dept. of Game & Fish Field Office.





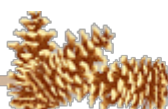

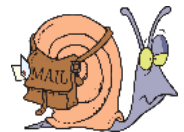
3) COMMUNITY CORNER
